What is the General Data Protection Regulation?

The General Data Protection Regulation (GDPR) comes into force in the UK on 25th May 2018. GDPR, which all employers must follow, will bring in stricter obligations than the existing Data Protection Act.

Data Protection Lead

Data Controllers and Data Processors

As an organisation that collects information from you, under GDPR, Care & Repair England is known as a **Data Controller**. Care & Repair England will always tell you how and why your personal data is processed.

Once we process the information you have provided us with Care & Repair England will also become **Data Processors**. In addition any organisations that we have shared your data with, that then process that data will also be **Data Processors**. Care & Repair England have a responsibility to ensure that we abide by data protection law and that any data processors we work with must themselves abide by rules to maintain records of their processing activities. For example if you are an employee of Care & Repair England we will share some of your personal data for salary purposes with our payroll bureau. In turn the payroll bureau become the data processors.

Staff /Trustees/Associates

We will use your information during the period of your involvement/employment with Care & Repair England. Once you are no longer involved with Care & Repair England we will only retain the information about you which is necessary in order to enable Care & Repair England to meet its legal obligations. All other information will be destroyed.

For staff members we will share relevant salary information with our payroll bureau, currently provided by Community Accounting Plus.

For former staff members we will keep the information necessary to enable us to supply a reference to potential future employers or provide pension, tax, NI or related legally required employment information.

All information will be kept secure in a locked filing cabinet & in restricted electronic files.

Electronic Equipment

Equipment used by employees in order to perform their work tasks such as personal computers and mobile phones are password protected.

What information do we collect about you?

We collect information about you when you register to receive information from us. We collect information about you to provide services to you.

We also collect information when you apply to attend events/training courses, apply to use our services or voluntarily complete our surveys/evaluation.

How will we use the information about you?

The way we use your information will depend on which of our services you use, receive information/updates, events and opportunities.

We will use your personal details to provide information about the training course you are booked to attend and any follow up resources or evaluation that you have agreed to receive.

Events attendees

We will use your personal details to provide information about the event you are booked to attend and any follow up resources or evaluation that you have agreed to receive.

We will not share your information with any other organisations for any purposes without obtaining your express permission.

Access to your information and correction

Cookies

Cookies are text files placed on your computer to collect standard internet log information and visitor behaviour information.
